


# Three Key Changes Affect How You Can Deploy Java SE in Your Enterprise:

- 1) Java SE 8: "End of Public Updates" for commercial use since January 15, 2019. Java SE 8: final Java SE release with 32 bit Support and Web Start support
- 2) As of March 2018, Java SE has a new six month cadence to deliver innovations and enhancements to developers on a faster and more predictable schedule.
- 3) Java Users must either
  - 1) update to a free current OpenJDK release, or
  - 2) invest in an Oracle Java SE Subscription to receive patches also for old releases (7, 8, LTS 11).
- Call to Action: Take control over when and how your production applications will take advantage of these key changes.



## Critical Patch Updates, Security Alerts and Bulletins

- **Bundled Patch Release** (BPR): full JDK, JRE and Server JRE deliverable built on the most recent PSU/CPU released, plus fix(es) requested by supported customer(s) or Oracle internal product group(s); build numbers start at b31 and increment upwards (b31, b32, etc.)
- CPU (Security Update) releases follow a quarterly schedule and they will be released on the Tuesday closest to the 17th day of Jan, Apr, July, and Oct.

Oracle provides this Oracle Java SE Support Roadmap, to help understand maintenance and support options and related timelines. If you are looking for the latest free JDK releases and updates from Oracle under an open source license, please see jdk.java.net. We recommend you take some time to understand the new Java SE release cadence and OpenJDK builds from Oracle so that you can make the best decisions for your corporate and personal use.

The guidance below applies to three types of Java users:

Oracle Customers. Oracle Customers are those Oracle customers with an active (1) Java SE Subscription and/or Java SE Desktop Subscription, (2) support contract for Oracle Java SE Advanced, Oracle Java SE Advanced Desktop, Oracle Java SE Suite, and/or Java SE Support, or (3) Java SE support entitlement for use of Java SE solely with another Oracle product (Visit My.Oracle Support Note 1439822.1 - All Java SE Downloads on MOS – Requires Support Login).

**Commercial Users**. Commercial Users are entities other than Oracle Customers that use Java SE for free for business, commercial or production purposes as part of a Java application delivered by a third party or developed internally.

**Personal Users.** Personal Users are individuals who use Java SE for free on personal desktops or laptops. Personal users include individuals using Oracle Java SE to develop applications for hobby or educational purposes, play games or run consumer productivity applications.

  - The license and resulting support associated with Oracle WebLogic Server SE and EE has always employed a 'restricted use' Oracle Java SE license which simply means that the customer has the appropriate license and support for Oracle Java SE for the sole purpose of running the Oracle WebLogic Server product.
  - Only those Weblogic clients are sufficiently supported, which are based on Weblogic specific Client-Technologies, like i.e. T3, JAX-RS, Forms and Reports

#### MOS Documentation:

This MOS document applies to WLS as well as other Oracle Products. Customers who have licensed an Oracle Product with support, which also requires Java SE, are licensed to use the Oracle Java SE run time for the sole purpose of running the Oracle Web Logic Server product.

## **Oracle Java SE Licensing FAQ**

## Important changes April 16, 2019

**Note**: In the event of a discrepancy between any part of this FAQ and the license under which you receive Oracle software, the latter shall be considered correct. This FAQ pertains to Oracle Java SE releases starting April 16, 2019.

### Oracle Java SE Licensing FAQ

#### What does the licensing change mean for me?

The previous Oracle Java SE license model had several options – some free under the Binary Code License ("BCL") and some paid under Oracle commercial terms. To simplify and provide full licensing transparency and clarity, Oracle as of Java 9 provides two distinct Java releases:

- Oracle OpenJDK releases under the open source GNU General Public License v2, with the Classpath Exception (GPLv2+CPE) (since Java 9), and
- Oracle Java SE product releases, which includes the Oracle JDK for Java 8 and later, and
  Oracle JRE with Java Web Start in Java 8, under the OTN License Agreement for Java SE. This
  license permits personal use, development, testing, prototyping, demonstrating and some other
  uses at no cost.

Different builds are provided for each Java release, but these builds are functionally identical aside from some cosmetic and packaging differences. More details are provided in our Roadmap document and summarized in this blog.

## Java SE Subscription - Licensing - 2

### **Definitions**

#### **Definitions**

Named User Plus: is defined as an individual authorized by you to use the programs which are installed on a single server or multiple servers regardless of whether the individual is actively using the programs at any given time. A non human operated device will be counted as a named user plus in addition to all individuals authorized to use the programs, if such devices can access the programs. If multiplexing hardware or software (e.g., a TP monitor or a web server product) is used, this number must be measured at the multiplexing front end. Automated batching of data from computer to computer is permitted. You are responsible for ensuring that the named user plus per processor minimums are maintained for the programs contained in the user minimum table in the licensing rules section; the minimums table provides for the minimum number of named users plus required and all actual users must be licensed.

For the purposes of the following Program: Java SE Desktop Subscription, the term "server" refers to a desktop computer.

**Processor:** shall be defined as all processors where the Oracle programs are installed and/or running. Programs licensed on a processor basis may be accessed by your internal users (including agents and contractors) and by your third party users. The number of required licenses shall be determined by multiplying the total number of cores of the processor by a core processor licensing factor specified on the Oracle Processor Core Factor Table which can be accessed at http://oracle.com/contracts. All cores on all multicore chips for each licensed program are to be aggregated before multiplying by the appropriate core processor licensing factor and all fractions of a number are to be rounded up to the next whole number. When licensing Oracle programs with Standard Edition One, Standard Edition 2 or Standard Edition in the product name (with the exception of WebCenter Enterprise Capture Standard Edition, Java SE Subscription, Java SE Support, Java SE Advanced, and Java SE Suite), a processor is counted equivalent to an occupied socket; however, in the case of multi-chip modules, each chip in the multi-chip module is counted as one occupied socket.

For example, a multicore chip based server with an Oracle Processor Core Factor of 0.25 installed and/or running the program (other than Standard Edition One programs or Standard Edition programs) on 6 cores would require 2 processor licenses (6 multiplied by a core processor licensing factor of .25 equals 1.50, which is then rounded up to the next whole number, which is 2). As another example, a multicore server for a hardware platform not specified in the Oracle Processor Core Factor Table installed and/or running the program on 10 cores would require 10 processor licenses (10 multiplied by a core processor licensing factor of 1.0 for 'All other multicore chips' equals 10).

# Web Deployment Technology and JavaFX

- Web Deployment Technology and JavaFX
- The Web Deployment Technology bundled with the JRE, consisting of the Java Plugin and Java Web Start has a shorter support lifecycle: only five years of Premier Support. The deployment stack was marked as deprecated and flagged for removal in Java SE 9 and Java SE 10. Oracle Java SE 11 and later versions will not include the Deployment Stack. As Java SE 8 will be the sunset release for the Deployment Stack (given that Java SE 9 and Java SE 10 are non-LTS releases) Oracle extended support of Java Web Start on Java SE 8 until the end of Java SE 8 Extended Support (March 2025). Support for the Java Plugin (Java Applets) remains available until March 2019.

Java SE 8 is the recommended and only supported version of the deployment stack, since versions earlier than Java SE 8 no longer include the deployment stack, while Java SE 9 has reached end of extended support, and Java SE 10 will reach end of extended support in September 2018. The Java SE 8 deployment stack may be used to run Java SE 6, or Java SE 7 applications on Windows platforms. The Java deployment technology will not be supported beyond Java SE 8. See the Oracle Lifetime Support Policy for details.

JavaFX has been <u>Open Sourced</u> and redesigned to be available as a stand-alone library rather than being included with the JDK. Starting with Java SE 11 (18.9 LTS), <u>JavaFX will not be included in the Oracle JDK</u>. Support for JavaFX on Java SE 8 will continue through the Premier Support term (until March 2022).

## JDK 9+: jlink Tool (incl. example for Windows)

- Generates a self-contained application bundle in a single folder of user's hard drive that includes:
  - → Application code + Embedded JRE + Native launcher (batch file)
- Bundles a stripped-down JRE incl. only those modules required by application

```
jlink [options] --module-path <modulepath> --add-modules <mods> --launcher <launcher_name>= <root_module> --output <path>
```

--module-path - defines where to look for compiled module binaries (e.g. jar, jmod)
```

- --add-modules names of modules (incl. its transitive dependencies) to add to the application bundle
- --output specifies name of subdirectory in which to place the resulting bundle
- --launcher name of laucher executable (if main class exists)
